Sweepstake Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **DESCRIPTION.**

The Contentful-Road Runner Sports Sweepstake ("Sweepstake") begins on October 22, 2024, at 12 am PST and ends on October 23, 2024, at 11:59 pm PST (the "Promotion Period").

The Sponsor of the Sweepstake is Contentful, Inc. ("Sponsor" or "Contentful"). By participating in the Sweepstake, each participant or entrant ("Entrant") unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission, or processing of Entries and the overall administration of the Sweepstake. Entrants should look solely to Sponsor with any questions, comments, or problems related to the Sweepstake. Sponsor may be reached by email at internal-events@contentful.com during the Promotion Period.

2. ELIGIBILITY.

You must be one (1) of the first 50 Entrants during the Promotion Period to reshare the LinkedIn post for this event that is pinned to our Contentful company page <u>and</u> have such reshare confirmed by Sponsor or its authorized representative.

<u>Additional Eligibility Criteria</u>: Notwithstanding the foregoing, this Sweepstake is: Open only to legal residents of the following authorized countries: fifty (50) United States and the District of Columbia who are twenty-one (21) years of age or older ("Entrant"). Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales





representatives, advertising and promotion agencies, and each of their respective officers, directors, and employees (the "Promotion Entities"), are ineligible to enter the Sweepstake or win a prize. Only one prize per person and per household will be awarded during the Promotion Period. Prizes cannot be resold or transferred to other parties, redeemed for cash, or substituted by the winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the ARV of the prize turns out to be less than the stated value, the difference will not be awarded in cash. Sponsor makes no representation or warranty concerning the appearance, safety, or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items.

This Sweepstake is open only to legal residents of the fifty (50) United States and the District of Columbia, and the Prize will only be awarded and/or delivered to addresses

4. **HOW TO ENTER**.

Enter the Sweepstake during the Promotion Period by resharing the LinkedIn post for this event that is pinned to our Contentful company page and have such reshare confirmed by Sponsor or its authorized representative.

5. **WINNER SELECTION**.

The winners of the Sweepstake will be selected randomly from the first fifty (50) among all eligible Entrants throughout the Promotion Period ("Winner"). The review of the eligibility of Entrants and confirmation of Winners will be conducted in person and real-time during the Promotion Period by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the timing and number of eligible entries received.

6. **WINNER NOTIFICATION**.

Winners will be notified in person and in real-time if they are confirmed as being in the first fifty (50) of all eligible Entrants. Sponsor is not responsible for any delay or failure of a Winner to acknowledge or receive notification for any reason.

For the purposes of this Section (Personal Data), "Agents" shall mean Program contractors, suppliers, and subcontractors.

8. **COMPLIANCE WITH LAWS**.

Entrant agrees to comply with all applicable laws, regulations, ordinances, and executive orders of any country, state, municipality, or government body applicable to (i) the Sweepstake, and (ii) Entrant's participation in the Sweepstake, and Entrant will indemnify, defend and hold harmless Sponsor and Sponsor's directors, officers, agents, employees, vendors, and suppliers from and against any and all claims, demands, actions, litigation, investigations, and proceedings arising out of or related to (a) the Sweepstake, (b) obligation to pay all taxes associated with any prize awarded under the Sweepstake; (c) participation in the Sweepstake; (d) any claims of employment, retention, hiring and/or any entitlement related thereto (including but not limited to pension, CPF, insurance or





other benefits) by participant against Sponsor or its agents; or (e) Entrant's breach of these rules.
